COMMENTARY

International Arrivals

Total arrivals for the first quarter 2020 were 8,340. This is a decrease of 48.6% compared to the previous quarter (4th quarter 2019). Compared to the same quarter a year ago, a decrease of 29.6% was recorded.

Returning residents made up 50% of arrivals for first quarter 2020. This was followed by Visitors with 49% of arrivals and the remaining less than 1% were Intending residents.

Visitor arrivals for the first quarter decreases by 49.7% to 4,080 visitors, compared to the fourth quarter 2019 figure of 8,109 visitors. There was a decrease of 32.2% in visitors arrivals from first quarter 2019 to first quarter 2020.

Chart 1 shows that the returning and visitors categories make up the largest proportions of all arrivals while the intending resident category makes up the lesser share this quarter. This information comes from table 1: Total Arrivals to the Solomon Islands by Purpose of Travel by Sex: 1st Quarter 2016 to 1st Quarter 2020.




Chart 1: Arrivals By Category 1st Quarter 2020

Visitors by Country of Residence


Arrivals by country of residence for the first quarter 2020 showed that Australians (39.9%) remain the largest group of visitors to the Solomon Islands. There was a decrease of 41.0% to 1,626 in Australian visitors compared to the fourth quarter of 2019 figure 2,757.

The next largest group of visitors were from Other Asians (10.3%), followed by Fiji (9.7%), Papua New Guinea (7.8%), New Zealand (6.9%), Other Pacific (5.6%), United State of American(5.1%) and Japan (2.5%). Table 2 shows detailed information on Visitor Arrivals to the Solomon Islands by Country of Residence: 1st Quarter 2017 to 1st Quarter 2020.

Visitors by Month

Visitor arrivals by month showed that January recorded the highest number of arrivals in the first quarter of 2020 with 1,857 visitors. This was followed by month of February with a total of 1,471 visitors and March the least with 752 visitors. This information comes from Table 3: Visitor Arrivals to the Solomon Islands by Month: January 2009 – March 2020.


Chart 2: Visitor Arrivals by Month, January 2018 - March 2020



Tourists

First quarter 2020 recorded a total of 1,405 tourists and they spent an average of 14.3 days in the country. Australian residents still made up the highest proportion of tourists (42.3%) for the quarter and stayed in the country for an average of 15 days. Residents from Other Asia made up the next largest group of tourists (8.5%), followed by Other Pacific (8.4%), Papua New Guinea (6.0%) and United States of America (5.8%) Refer to Table 4: Visitors to the Solomon Islands Classified as Tourists by Country of Residence and Average Length of Stay (in days): 1st Quarter 2018 to 1st Quarter 2020.

Visitors by Purpose of Visit

The most common reason for visitors visiting the Solomon Islands during the quarter was for Holiday and Vacation (28.1%). This was followed by visiting for other Reasons (25.0%), Business and Conference (24.3%), Visiting friends and relatives (16.3%) and Transit & Stop over (6.3%). 


Chart 4: Percentage of Visitor Arrivals to the Solomon Islands by Purpose of Visit, 1st Quarter 2020

Visitors by Age Group

The distribution of visitor arrivals by broad age groups for first quarter 2020 showed that 75.2% of Visitors were in the 25 years to 64 years age range. The youngest age group, 0 -24 years, represented 12.8% of the arrivals while the oldest age group, 65 years and over made up 7.8% of total visitor arrivals. The remaining 4.1% were visitors who did not state their age. Male visitors represented more than half of the total visitors arrivals (70.3%) and female visitors made up 29.7% of arrivals this quarter. Visitors by Occupation

Visitor by Occupation showed that the "Other occupation" category mades up the largest percentage of occupations (41.7%) during the quarter. This was followed by "Professional and Technical" (30.3%), No work (11.4%), Administration and Managerial position (9.1%), and Production and Related work (3.1%). Visitor by Carrier

The most popular carriers during the quarter were Solomon Airlines who carried (53.2%) of total visitors, followed by Air Niugini (20.4%) and Virgin Australia (16.4%).

Visitor Arrivals to Munda

Arrivals by country of residence to Munda for first quarter 2020 showed that Australians (81.5%) recorded the largest group of Visitors. This was followed by visitors from New Zealand with (7.5%) and Other Asians with (3.5%) of the arrivals. ABOUT THE BULLETIN

Concepts and Definitions

Persons entering Solomon Islands classify themselves into three (3) categories; returning resident, intending resident, and visitor. The concepts and definitions of the various categories are as follows:

(i) Returning residents

- Solomon Islanders and non-Solomon Islanders who have left the country and are returning to continue their residence.
- Non Solomon Islanders includes resident permit holders and Diplomatic officials, and their immediate family members. This may also include legal or official arrangements that fall outside of the above.

(ii) Intending residents

Non-Solomon Islander who wish to take up residence in Solomon Islands.

(iii) Visitors

- Any traveler who is not a Solomon Islander and their stay and intention of stay should last no more than 12 months¹, in the country and does not have a permanent/contract employment.
- Tourist
 - Visitors who further classify themselves stating their visit are purposely for 'holiday and vacation'. This exclude, tourist arrivals by cruise ships.
 - Wife accompanying husband on business purpose is a private tourist unless also working.
 - World Tourism Organization WTO definition of Tourism:
 It comprises the activities of persons travelling to and staying in places outside their usual environment for not more than one consecutive year for leisure, business and other purposes not related to the exercise of an activity remunerated from within the place visited.

(iv) Markets

Country of Usual Residence is referred to as 'markets' by the Solomon Islands Visitors Bureau

Note: For Quarter 1 2018 onwards the National Statistics Office will be using the new set of definitions provided by the South Pacific Tourism Organization (SPTO).

Relevance:	Data topic: The data represents returning residents, intending residents and visitor arrivals to the Solomon Islands. Data is mainly from air arrivals.
	Level of geography: The data mainly covers arrivals to Honiara. However, from March 2019, the data will also cover air arrivals to Munda.
	Key Data Items: The key variables produced in this bulletin are the sex, age group, carrier, and occupation, country of residence, and purpose of visit for visitors including tourists.
	Additional information: Visitor statistics were collected for the Solomon Islands Visitor's Bureau for the purpose of planning and for the Central Bank of Solomon Islands for monitoring the tourism sector of the economy. Other users may use the information for research.
	 The data is coded using the United Nations Country Classification and the Pacific Standard Classification of Occupations. The data does not cover cruise ship arrivals and yacht arrivals. It also does not cover the monetary value of the industry as this information is not available. Data prior to 2006 were not available from the data source due to civil unrest period 1998 to 2003.
Timeliness:	Data collected: The data is collected continuously.
	Data available: The data and published bulletin is usually available 2 months after the end of the previous quarter.
	Referenced Period: The data is collected daily over each quarter and published on quarterly basis.
Accuracy:	Method of Collection: The data is collected through all disembarking passengers self-completing a visitor arrivals card. Immigration officers at international check in counters collect the card on arrival. The Department of Immigration have an

arrangement with the Solomon Islands' National Statistics Office where they collect the disembarkation cards for the production of visitor arrival statistics. Data Adjustments: Quality check between immigration and SINSO is done monthly and adjustment of data can be made by SINSO where necessary. **Collection size:** The collection size is the entire population of air passenger arrivals to the Solomon Islands. **Under Counts:** There is a known undercount of visitor arrivals to the Solomon Islands. Measures have been put into place to improve the transfer of information between departments. The current definition of visitor and returning residents may result in an undercount of visitor arrivals. This issue is being resolved with stakeholders to ensure consistent definitions are being used. **Additional information:** Data on purpose of visit, age and occupation may not be correctly disclosed and may cause a bias.
