COMMENTARY

International Arrivals

A significant decline in international arrivals was recorded since restrictions were imposed on International flights by Solomon Island Government towards the end of March 2020, as part of the State of Public Emergency (SOPE) response towards preventing Solomon Island residents and citizens from the COVID-19 pandemic.

Total arrivals for third quarter of 2021 were 82. This is a decrease of 88.9% compared to the previous quarter (2nd quarter 2021). Compared to the same quarter a year ago, a decrease of 89.8% was recorded.

Returning residents made up 87.8% of arrivals for third quarter 2021. This was followed by Visitors with 12.2% of arrivals and the remaining 0.0% were Intending residents.

Visitor arrivals for the third quarter decreased by 94.4% to 10 visitors, compared to the second quarter 2021 figure of 177 visitors. There was a decrease of 94.8% in visitor arrivals from third quarter 2020 to third quarter 2021.

Chart 1 shows that the returning category make up the largest proportion of all arrivals while the visitors and intending resident categories make up the lesser share this quarter. This information comes from Table 1: Total Arrivals to the Solomon Islands by Purpose of Travel by Sex: 1st Quarter 2017 to 3rd Quarter 2021.




Chart 1: Arrivals By Category 3rd Quarter 2021

Visitors by Country of Residence

Arrivals by country of residence for the third quarter 2021 showed that Australia (50.0%) recorded the largest group of visitors to the Solomon Islands. There was a decrease of 90.1% to 5 in Australian visitors compared to the second quarter of 2021 figure 55.

The next largest group of visitors were from Japan (40.0%) followed by PNG (10.0%). Table 2 shows detailed information on Visitor Arrivals to the Solomon Islands by Country of Residence: 1st Quarter 2017 to 3rd Quarter 2021.

Visitors by Month

Visitor arrivals by month showed that September recorded the highest number of arrivals in the third quarter of 2021 with 10 visitors. There was zero (0) visitor recorded on month of July and August due to travel advisory measures which was imposed by Solomon Island Government to temporary suspend incoming passenger services in July. This information comes from Table 3: Visitor Arrivals to the Solomon Islands by Month: January 2009 – September 2021.

Tourists

Restrictions on international flights as part of the SOPE measure against Covid-19 pandemic had adverse implications on visitors travelling predominatly for tourism purposes. Third quarter 2021 recorded zero tourists whose purpose of travel was for holiday and vacation. Hence, there are zero days spent in transit by tourists/visitors in the country. 


Chart 3: Tourist by Country of Residence: 2nd Quarter 2021 – 3rd Quarter 2021

Visitors by Purpose of Visit

The most common reason for visitors visiting the Solomon Islands during the quarter was for other reason (100.0%). There was no visitor visiting Solomon Islands for Business and Conference, Transit and Stopover, Visiting friends and relatives, and Holiday and vacation during the quarter as noted earlier regarding tourist arrivals. Visitors by Age Group

The distribution of visitor arrivals by broad age groups for third quarter 2021 showed that 50.0% of visitors were in the 25 years to 64 years age range. The youngest age group, 0 -24 years were 0.0% and the oldest age group, 65 years and over represented 40.0% of total visitor arrivals. The remaining 10.0% were visitors who did not state their age. Male visitors represented more than half of the total visitors arrivals (90.0%) and female visitors made up 10.0% of arrivals this quarter. Visitors by Occupation

Visitor by Occupation showed that the "Professional and Technical" category made up the largest percentage of occupations (80.0%) during the quarter. This was followed by "Other Occupation" and "Clerical and Related work" (10.0%) respectively. Visitor by Carrier

The most popular carriers during the quarter were Solomon Airlines who carried (100.0%) of total visitors.

Visitor Arrivals to Munda

There was no record of visitors from Brisbane to Munda flights since the closing of International flights on end of March 2020.

ABOUT THE BULLETIN

Concepts and Definitions

Persons entering Solomon Islands classify themselves into three (3) categories; returning resident, intending resident, and visitor. The concepts and definitions of the various categories are as follows:

(i) Returning residents

- Solomon Islanders and non-Solomon Islanders who have left the country and are returning to continue their residence.
- Non Solomon Islanders includes resident permit holders and Diplomatic officials, and their immediate family members. This also includes persons residing for 12 months or more or under specialized legal or official arrangements.

(ii) Intending residents

Non-Solomon Islander who wish to take up residence in Solomon Islands.

(iii) Visitors

- Any traveler who is not a Solomon Islander and their stay and intention of stay should last no more than 12 months¹, in the country and does not have a permanent/contract employment.
- Tourist
 - o Visitors who state their purpose of travel as being for 'holiday and vacation' and 'transit'.
 - O Visitors who are transiting (with on-ward final destination) and have stated their purpose of travel as being for 'holiday and vacation' are treated as transit-tourists, and classified broadly as tourists. This includes limited number of visitors who are simply transiting for other purposes. The latter is subject to review as NSO continues to progressively align its definitions and concepts to meet changing regional and international standards.
 - Spouse/partner accompanying husband/wife/partner on business purpose is treated as a private tourist unless the person is also engaged in a similar or related work-activity remunerated within the place visited.
 - In line with World Tourism Organization WTO definition of Tourism:
 It comprises the activities of persons travelling to and staying in places outside their usual environment for not more than one consecutive year where pleasure is being the predominant motivation.

(iv) Markets

• Country of Usual Residence is referred to as 'markets' by the Solomon Islands Visitors Bureau.

Note: There may be some variations in the total number of visitor arrivals reported by the National Disaster Office/Ministry of Health under the government's State of Public Emergency response on COVID-19 pandemic and the NSO. However, the NSO will continue to adhere to its data collection process and dissemination of the results.

Note: For Quarter 1, 2018 onwards the National Statistics Office will be using the new set of definitions provided by the South Pacific Tourism Organization (SPTO).

	Key Data Items: The key variables produced in this bulletin are the sex, age group, carrier, and occupation, country of residence, and purpose of visit for visitors including tourists.
	Additional information: Visitor statistics were collected for the Solomon Islands Visitor's Bureau for the purpose of planning and for the Central Bank of Solomon Islands for monitoring the tourism sector of the economy. Other users may use the information for research.
	 The data is coded using the United Nations Country Classification and the Pacific Standard Classification of Occupations.
	 The data does not cover cruise ship arrivals and yacht arrivals. It also does not cover the monetary value of the industry as this information is not available. Data prior to 2006 were not available from the data source due to civil unrest period 1998 to 2003.
Timeliness:	Data collected: The data is collected continuously.
	Data available: The data and published bulletin is usually available 2 months after the end of the previous quarter.
	Referenced Period: The data is collected daily over each quarter and published on quarterly basis.
Accuracy:	Method of Collection: The data is collected through all disembarking passengers self-completing a visitor arrivals card. Immigration officers at international check in counters collect the card on arrival. The Department of Immigration have an arrangement with the

	Solomon Islands' National Statistics Office where they collect the disembarkation cards for the production of visitor arrival statistics.									
	Data Adjustments: Quality check between immigration and SINSO is done monthly and adjustment of data can be made by SINSO where necessary.									
	Collection size: The collection size is the entire population of air passenger arrivals to the Solomon Islands.									
	Under Counts: There is a known undercount of visitor arrivals to the Solomon Islands. Measures have been put into place to improve the transfer of information between departments.									
	The current definition of visitor and returning residents may result in an undercount of visitor arrivals. This issue is being resolved with stakeholders to ensure consistent definitions are being used.									
	Additional information: Data on purpose of visit, age and occupation may not be correctly disclosed and may cause a bias.									
	Data processing is mostly automated and quality checks are conducted.									
	Non reporting is an issue for this bulletin. Disembarkation cards are not always fully completed and the space for reporting on the cards also affects their completeness.									
	Cruise ship arrivals and yacht arrivals are unaccounted for in the data collected.
