## COMMENTARY

### International Arrivals

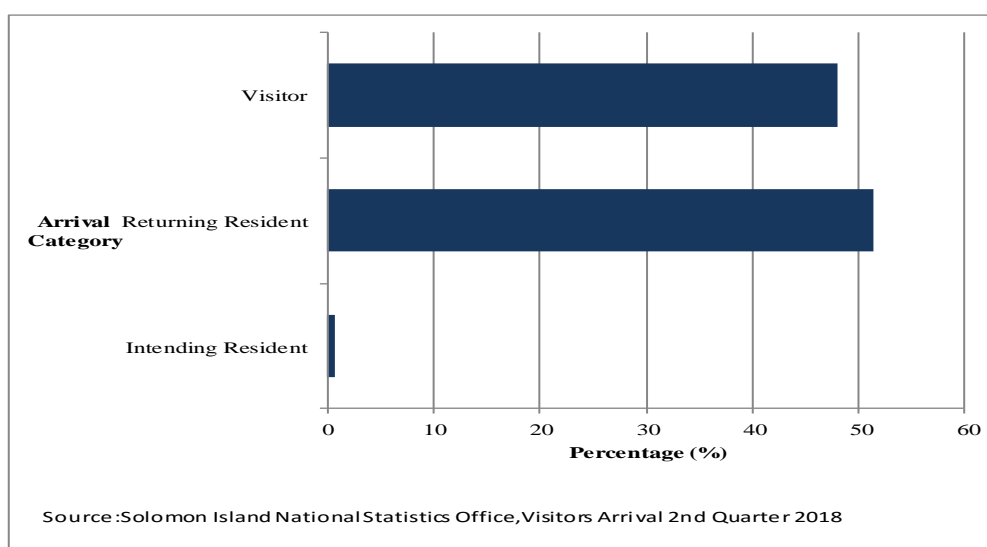
Total arrivals for the second quarter 2018 were 14,648. This is an increase of 26.4% compared to the previous quarter (1<sup>st</sup> quarter 2018). Compared to the same quarter a year ago, an increase of 13.2% was recorded.

Returning residents made up 51% of arrivals for second quarter 2018. This was followed by visitors with 48% of arrivals and the remaining 1% were intending residents.

Visitor arrivals for the second quarter increased by 11.5% to 7,021 visitors, compared to the first quarter 2018 figure of 6,296 visitors. There was a 9.3% increase in visitors arrivals from second quarter 2017 to second quarter 2018.

Chart 1 shows that the returning and visitors categories make up the largest proportions of all arrivals while the intending resident category makes up the lesser share this quarter. This information comes from table 1: Total Arrivals to the Solomon Islands by Purpose of Travel by Sex: 1st Quarter 2014 to 2nd Quarter 2018.

### Visitors by Country of Residence

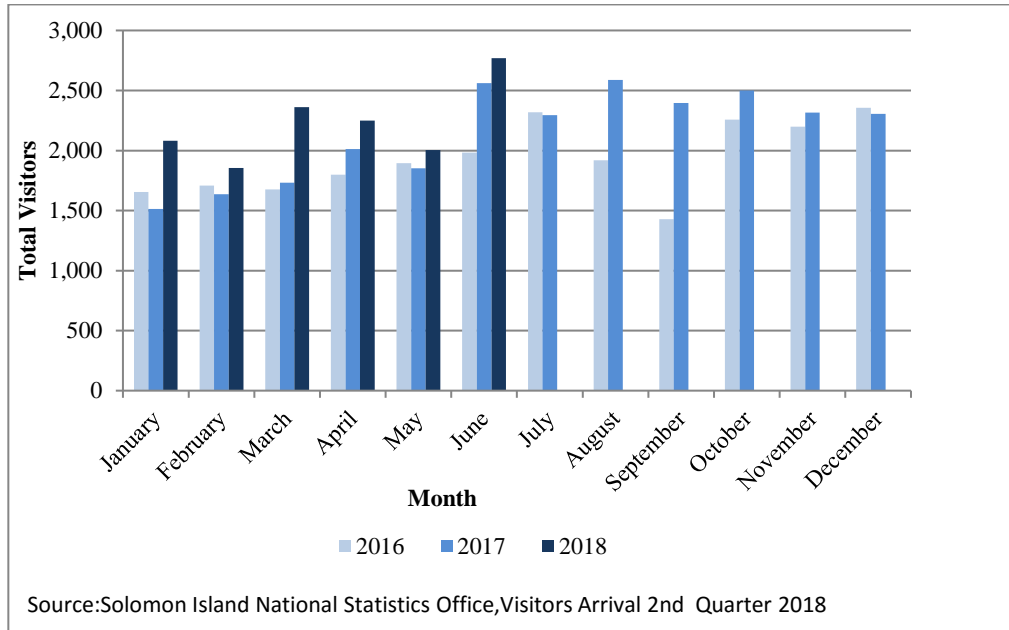
Arrivals by country of residence for the second quarter 2018 showed that Australians (35.2%) remain the largest group of visitors to the Solomon Islands. There was a 12.5% increase to 2,469 in Australian visitors compared to the first quarter of 2018 figure 2,195.

The next largest group of visitors were from Other Asia (10.5%), followed by Fiji (7.2%), Papua New Guinea (7.0%), New Zealand (6.8%), United States of America (6.7%) and Other Pacific (6.6%). ### Visitors by Month

Visitor arrivals by month showed that June recorded the highest number of arrivals in the second quarter of 2018 with 2,768 visitors. This was followed by month of April with a total of 2,250 visitors and May the least with 2,003 visitors. This information comes from Table 3: Visitor Arrivals to the Solomon Islands by Month: January 2008 – June 2018.

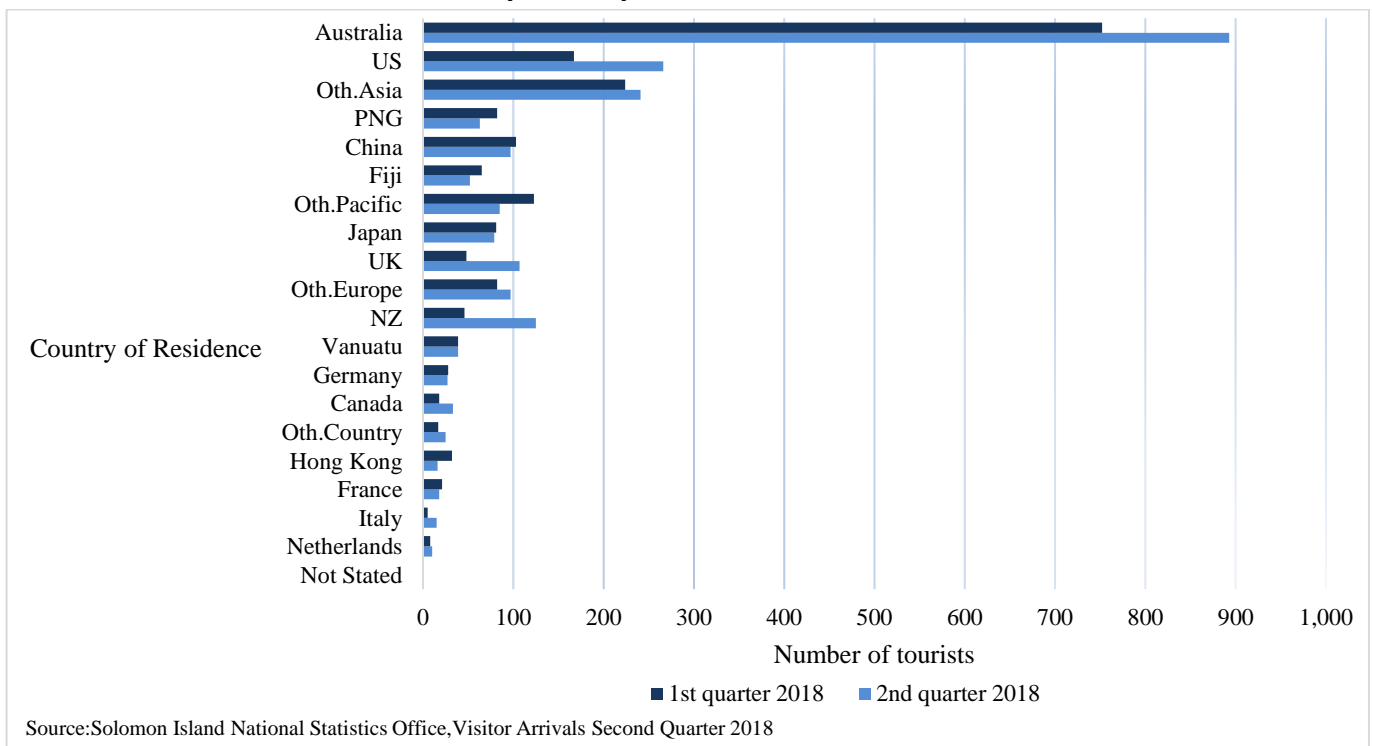
**Chart 2: Visitor Arrivals by Month, January 2016 – June 2018**



**Tourists**

Second quarter 2018 recorded a total of 2,340 tourists and they spent an average of 14.7 days in the country. Australian residents still made up the highest proportion of tourists (38.2%) for the quarter and stayed in the country for an average of 13.5 days. Residents from the United States of America made up the next largest group of tourists (11.4%), followed by Other Asia (10.3%), Other Europe (6.4%), New Zealand (5.3%), United Kingdom (4.6%), China (4.1%), Other Pacific (3.6%) and Japan (3.4%). 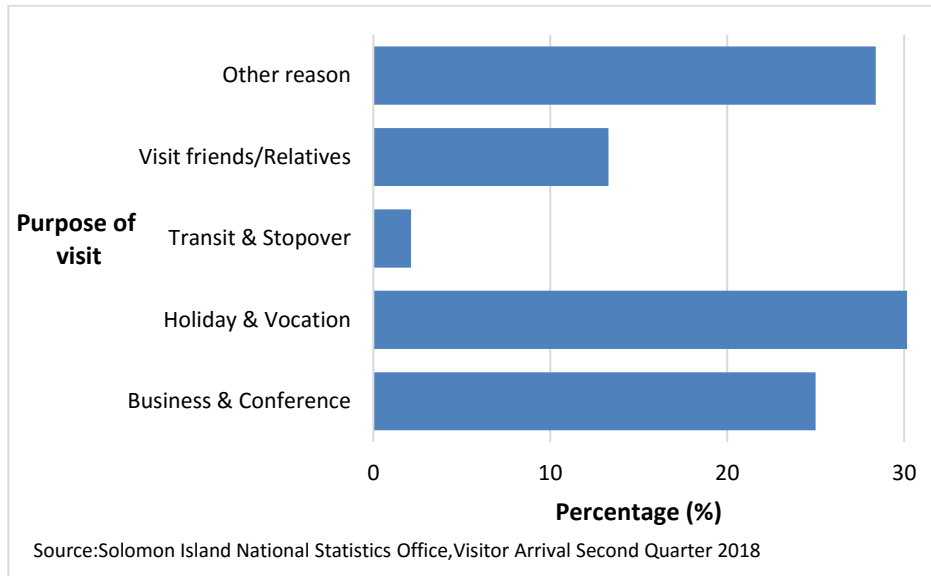

### Visitors by Purpose of Visit

The most common reason for visitors visiting the Solomon Islands during the quarter was for holiday (31.2%). This was followed by visiting for other reason (28.4%), Business and Conference (25.0%), visiting friends and relatives (13.3%) and transit & stop over (2.1%). ### Visitors by Age Group

The distribution of visitor arrivals by broad age groups for second quarter 2018 showed that 74.9% of Visitors were in the 25 years to 64 years age range. The youngest age group, 0 -14 years, represented 4.0% of the arrivals while the oldest age group, 65 years and over made up 9.8% of total visitor arrivals. The remaining 3.9% were visitors who did not state their age. Male visitors represented more than half of the total visitors arrivals (66.1%) and female visitors made up 33.9% of arrivals this quarter. ### Visitors by Occupation

Visitor by Occupation showed that the "Other occupation" category makes up the largest percentage of occupations (43.3%) during the quarter. This was followed by visitors who stated their occupation was from the professional and technical group (28%), no work (11.1%), administration and managerial position (10.3%) and production and related workers (2.2%). ### Visitor by Carrier

The most popular carriers during the quarter were Solomon Airlines who carried 41.7% of total visitors, followed by Air Niu Guinea (30.0%) and Virgin Australia (16.3%).

## ABOUT THE BULLETIN

### Concepts and Definitions

Persons entering Solomon Islands classify themselves into three (3) categories; returning resident, intending resident, and visitor. The concepts and definitions of the various categories are as follows:

#### *(i) Returning residents*

- Solomon Islanders and non-Solomon Islanders who have left the country and are returning to continue their residence.
- Non Solomon Islanders includes resident permit holders and Diplomatic officials, and their immediate family members. This may also includes legal or official arrangements that fall outside of the above.

#### *(ii) Intending residents*

- Non-Solomon Islander who wish to take up residence in Solomon Islands.

#### *(iii) Visitors*

- Any traveller who is not a Solomon Islander and their stay and intention of stay should last no more than 12 months<sup>1</sup>, in the country and does not have a permanent/contract employment.
- *Tourist*
  - Visitors who further classify themselves stating their visit are purposely for '*holiday and vacation*'. This exclude, tourist arrivals by cruise ships.
  - Wife accompanying husband on business purpose is a private tourist unless also working.
  - World Tourism Organization WTO definition of Tourism:  
It comprises the activities of persons travelling to and staying in places outside their usual environment for not more than one consecutive year for leisure, business and other purposes not related to the exercise of an activity remunerated from within the place visited.

#### *(iv) Markets*

- Country of Usual Residence is referred to as 'markets' by the Solomon Islands Visitors Bureau
