Introduction

This quarterly bulletin is produced by the National Statistics Office (NSO) in the Ministry of Finance and Treasury. It provides information on international arrivals comprised of the returning resident, intending resident, and visitor. The explanation of these categories is provided in Appendix 1 of the bulletin.

The bulletin includes twelve tables and eight charts to meet information needs of local, regional, and international researchers. The visitors' category makes up the biggest share of the bulletin, (portrayed in tables 1 to 8); compared to the returning and intending resident categories portrayed in Tables 1, and 9 to 12.

The information was captured through a self-completed visitor arrivals card that was completed by all passengers disembarking in the Solomon Islands. The cards were collected by Immigration officials at international check-in counters on arrival. The coverage of the bulletin is complete.

The NSO acknowledges the Immigration Department for their continuous support of this bulletin, by providing an office space and permitting the NSO to use completed cards to produce statistics. This bulletin is only possible because of the official arrangements in-place between the NSO and the Immigration department.

The inclusion of four new tables, tables 9 to 12, in Appendix 2 of the bulletin anticipates to complete the distribution portrait of intending and returning residents. The distribution is by age group, occupation and by country of usual residence.

Data limitations, highlighted in the previous bulletin still remain, though some have substantially improved but they are noted again for ease of reference:-

- Data entry duplication by the Immigration and Statistics departments is a long standing issue. The two departments have discussed the issues and though a resolution has been recognized, this is yet to be put in place.
- The timeliness of visitor statistics has improved but the bulletin may be delayed by the production process.
- The information contained in the bulletin is based on information captured from the data source by the SINSO.
- The monetary value of the industry is not available and thus not possible in this bulletin. The concepts and definitions of the arrival categories were included in Appendix 1. The symbols that are likely to be used are:
 - Zero if representing a value
 - negative change if representing a percentage change
 - + positive change if representing a percentage change
 - p preliminary figure, subject to revision
 - r revised
 - e estimate
 - n/a not available

COMMENTARY OF RESULTS

International Arrivals

Total arrivals for the first quarter 2018 were 11,593. This is a decrease of 28.5% compared to the previous quarter (4th quarter 2017). Compared to the same quarter a year ago, an increase of 15.6% was recorded. Visitors made up 54 % of arrivals for first quarter 2018. 45% of arrivals were Returning residents and the remaining 1% were intending residents.

Visitor arrivals for the first quarter decreased by 11.6% to 6,296 visitors, compared to the fourth quarter 2017 figure of 7,122 visitors. There was a 29.0% increase in visitor arrivals from first quarter 2017 to first quarter 2018. Table 1 shows that the returning and visitors categories make up the largest proportions of all arrivals while the intending resident category makes up the lesser share this quarter. Chart 1 gives a clear picture of all the categories.

Visitors by Country of Residence

Arrivals by country of residence for the first quarter 2018 showed that Australians (34.9%) remain the largest group of visitors to the Solomon Islands. The next largest group of visitors were from Other Asia (15.1%), followed by Fiji (7.2%), Other Pacific (6.5%), Papua New Guinea (6.2%), New Zealand (5.7%) and the United States of America (5.1%). Table 2 shows detailed information on visitor arrivals by country of residence.

Visitors by Month

Visitor arrivals by month showed that March recorded the highest number of arrivals in the first quarter of 2018 with 2,360 visitors. This was followed by month of January with a total of 2,081 visitors and February the least with 1,855 visitors.

Tourists

1,941 tourists arrived in first quarter 2018 and they spent an average of 15.5 days in the country. Australian residents still made up the highest proportion of tourists (38.7%) for the quarter and stayed in the country for an average of 11 days. Residents from Other Asians made up the next largest group of tourists (11.5%), followed by United States of America (8.6%), Other Pacific (6.3%), China (5.3%), Papua New Guinea, Japan and Other Europe, (4.2%).

Visitors by Purpose of Visit

The most common reason for visitors visiting the Solomon Islands during the quarter was for other reason (28.3%). This was followed by visiting for holiday or vacation (27.0%), Business and Conference (26.1%), visiting friends and relatives (14.7%) and transit & stop over (3.8%).

Visitors by Age Group

The distribution of visitor arrivals by broad age groups for first quarter 2018 showed that 77.1% of Visitors were in the 25 years to 64 years age range. The youngest age group, 0 -14 years, represented 4.5% of the arrivals while the oldest age group, 65 years and over made up 7.1% of total visitor arrivals. The remaining 4.6% were visitors who did not state their age. Male visitors represented more than half of the total visitors arrivals (70.9%) and female visitors made up 29.1% of arrivals this quarter. (Refer to chart 6)

Visitors by Occupation

Visitor by Occupation showed that the “Professional and technical” category makes up the largest percentage of occupations (30.8%) during the quarter. This was followed by visitors who stated their occupation was from the other occupation group (29.9%), administration & managerial positions (14.1%), no work (9.2%) and production and related workers (5.3%). Refer to Table 7 for further analysis.

Visitor by Carrier

The most popular carriers during the quarter were Solomon Airlines who carried 43.6% of total visitors, followed by Air Niue (29.5%) and Virgin Australia (18%).

Chart 1: Arrivals by Category 1st Quarter 2018



Chart 2: Visitor Arrivals by Country of Residence by quarter: 4th Quarter 2017 to 1st Quarter 2018



Chart 3: Visitor Arrivals by Month, January 2016 –January 2017



Chart 4: Tourist Arrivals by Country of Residence: 4th Quarter 2017- 1st Quarter 2018



Chart 5: Visitor Arrivals by Country of Residence by Purpose of Visit, 1st Quarter 2017



Chart 6: Visitor Arrivals by Age group by Sex, 1st Quarter 2018



Chart 7: Visitors Arrival by Occupation by Sex, 1st Quarter 2018




Appendix 1

Concepts and Definitions

People entering the Solomon Islands classify themselves into three (3) categories; returning resident, intending resident, and visitor. The concepts and definitions of the various categories are as follows:

(i) Returning residents

- Solomon Islanders and non-Solomon Islanders who have left the country and are returning to continue their residence.
- Non Solomon Islanders includes resident permit holders and Diplomatic officials, and their immediate family members. This may also includes legal or official arrangements that fall out side of the above.

(ii) Intending residents

- Non-Solomon Islander who wish to take up residence in Solomon Islands.

(iii) Visitors

- Any traveller who is not a Solomon Islander and who purposely spends less time – at most a period of 120 days¹, in the country and with the intention and purpose of visiting.
- *Tourist*
 - Visitors who further classify themselves as stating their visit is purposely for '*holiday and vacation*'. This exclude, tourist arrivals by cruise ships.
 - Spouses accompanying spouses on business trips are private tourists unless also working.
 - *World Tourism Organization definition of Tourism:*
*It comprises the activities of persons travelling to and staying in places outside their usual environment for not more than one consecutive year for leisure, business and other purposes not related to the exercise of an activity remunerated from within the place visited*².
